# Attestation Report on Pre-issuance of Bank of China Hungarian Branch's 2022 Green Bond

#### To the Directors of Bank of China Limited

We have been engaged by Bank of China Limited (the "Bank") to examine the assertions in the accompanying the *Description on Bank of China Hungarian Branch's 2022 Green Bond* (the "Description"), and expressed a limited assurance conclusion on the Description.

#### Criteria

The Description is prepared in accordance with the *Green Bond Principles 2021* published by International Capital Market Association.

### Management's Responsibility

The management of the Bank (the "Management") is responsible for:

- Preparation of the Description in accordance with the *Green Bond Principles 2021*, and to ensure the fair presentation, accuracy, completeness and validity of the information contained in the Description;
- Design, implement and maintain necessary internal controls in accordance with Bank of China Limited Sustainability Series Bonds Management Statement in meeting the criteria in relation to use of proceeds, project evaluation and selection, management of proceeds, and reporting as set out in the Green Bond Principles 2021.

## Assurance Practitioner's Responsibility

We conducted our limited assurance engagement in accordance with *International Standard on Assurance Engagements 3000 (Revised): Assurance Engagements Other than Audits or Reviews of Historical Financial Information* issued by the International Auditing and Assurance Standards Board.

Our responsibility is to express an independent limited assurance conclusion as to whether anything has come to our attention to cause us to believe that the Description, in all material respects, does not meet the Criteria.



#### **Our Procedures**

Our procedures performed included, but not limited to:

- Read the policies and procedures established by the Bank related to the issuance of the Bank of China Hungarian Branch's 2022 Green Bond;
- Interviewed personnel of selected business units to understand the key issues in relation to the above policies and procedures;
- Reviewed the Bank's policies and procedures in relation to the use and management of proceeds for the Bank of China Hungarian Branch's 2022 Green Bond;
- Reviewed the Bank's policies and procedures in relation to how Management evaluated and selected appropriate project(s) for the Bank of China Hungarian Branch's 2022 Green Bond;
- Reviewed the Bank's policies and procedures in relation to how Management compiled information and disclosed appropriately in the relevant documentation for the Bank of China Hungarian Branch's 2022 Green Bond; and
- Reviewed the eligibility of all the nominated projects for inclusion in the Bank of China Hungarian Branch's 2022 Green Bond.

#### Conclusion

Based on our procedures performed, as described in this report as of 7 February 2022, nothing has come to our attention that causes us to believe that the assertions in the Description on the use of proceeds, project evaluation and selection, management of proceeds, and reporting of the Bank of China Hungarian Branch's 2022 Green Bond, in all material respects, does not meet the criteria as set out in the *Green Bond Principles 2021*'s pre-issuance requirement.

#### Limitations

There are inherent limitations, for example, assurance engagements are based on selective testing of the information being examined and it is possible that fraud, error or non-compliance may occur and not be detected. A limited assurance engagement is substantially less in scope than a reasonable assurance engagement in relation to both the risk assessment procedures, including an understanding of internal control, and the procedures performed in response to the assessed risks. There are additional inherent risks associated with assurance over non-financial information including reporting against standards which require information to be assured against source data compiled using definitions and estimation methods that are developed by the reporting entity. Finally, adherence to the Description are subjective and will be interpreted differently by different stakeholder groups.

Our work is substantially less in scope than an audit conducted in accordance with International Standards on Auditing issued by the International Auditing and Assurance Standards Board. Accordingly, we do not express an audit opinion. Our assurance is limited to the Bank of China Hungarian Branch's 2022 Green Bond issuance, and does not include statutory financial



statements. Our assurance is limited to policies and procedures in place as at 7 February 2022, ahead of the issuance of the Bank of China Hungarian Branch's 2022 Green Bond.

Our responsibility in performing our procedures and reporting thereon is to the Bank only and in accordance with terms of reference for this engagement as agreed with them.
